1. Terms and Conditions

1.1 These terms and conditions (Terms) apply to any person (Participant) who enters Sunday Sessions (Competition) delivered by Access Health and Community (AccessHC). By entering the Competition, Participants agree to be bound by these Terms.


2. Prize and Eligibility

- **2.1** To be eligible to win, Participants must:

4. Notification of Competition Outcome


- **4.1** The winner will be notified by email and will be asked to provide their mailing address for delivery of the Prize.
- 4.2 If the winner does not provide their delivery details to AccessHC within 7 days of receiving a message from AccessHC the prize winner will lose their right to claim with Prize and the Prize will be awarded to another randomly selected winner.
